Bison Bridge Project Seeks IA-ASLA Chapter Endorsement.

During the Fall Conference Keynote Session, Chad Pregracke with Living Lands and Waters shared with the audience plans for the recently announced Bison Bridge Project. With replacement of the I-80 Bridge over the Mississippi between LeClaire IA and Rapids City, IL in the next decade or so, this ambitious project envisions the preservation and conversion of the existing bridge span as an adaptive re-use living bridge/multi-modal

connection/event venue/tourist destination anchored by a wildlife refuge at either end, complete with a roaming bison herd.

Nebraska/Dakotas Awards Recap


