tenured partners as well as additional sponsors through the Central States Partnership Program.



#### NATIONAL CONFERENCE RECAP

The Conference on Landscape Architecture was held November 11-14<sup>th</sup> in San Francisco. As always, the conference is a great way to reconnect with classmates, colleagues, and vendors. It can best be described as the perfect way to 'fill up one's LA bucket' until next year. In true fashion, San Francisco did not disappoint.

Prior to the conference starting, Nate Byro and I attended the Chapter President's Council meeting alongside Michael Gaunt who attended the Board of Trustee Meeting. It was during the combined first session that we had the chance to brainstorm with other chapters about what we find most challenging for our chapter at the current moment. Common themes were volunteer burnout, membership retention & helping non-members and/or lapsed members see the benefit of membership. Overall, the chapter has seen a 10% increase in membership over the last year. I'm hopeful that number will continue to increase as we move into 2023. We also were given additional information on the Fellows Application process and the Uniform Licensure Standard. New to the conference this year was the availability of field sessions on the last day of the conference, Monday the 14<sup>th</sup>. I was able to attend the session at Alcatraz and enjoyed a private tour of the garden spaces on the island which are primarily maintained by volunteers. There are over 200 survivor plants on the island that date back to its founding. Relics from years of military control can be found throughout the site but what I found most compelling were the markings left during the occupancy of Native American tribes. Another event that I attended while at the conference was the Landscape Architecture Foundation Annual Benefit. During the benefit the 2021-22 Olmsted Scholars were honored which included Megan Keleher from Iowa State. Finally, I was able to attend the President's Dinner and it has by far become my favorite event of the conference. Kene Okigbo from the Nebraska/Dakotas Chapter was honored with the Emerging Professional of the Year award. He was among many other notable winners including Ebru Ozer (Community Service Award), Kofi Boone (Jot D. Carpenter Medal for Excellence in Teaching), and Shawn Kelly (ASLA Medal). The evening culminated with Emily O'Mahoney becoming the next president of the society, currently placing women in the top 3 positions of our society for the first time in history. Eugenia Martin (Past-President) and SuLin Kotowicz (President-Elect) complete the trifecta.

Just like Nashville, the conference in San Francisco gave us all an opportunity to kick back and celebrate the past year's achievements and milestones. I would challenge all of our members to make the commitment to attend the 2023 Conference on Landscape Architecture when it is Minneapolis!


#### NATIONAL CONFERENCE STUDENT EXPERIENCES

In 2021, ASLA was a signatory of the International Federation of Landscape Architects (IFLA) Climate Action Commitment, which was presented at the UN Framework Convention on Climate Change (UNFCCC) 26<sup>th</sup> Conference of the Parties (COP26) that convened in Glasgow, Scotland.

The ASLA Climate Action Plan is rooted in three goals and six initiatives of IFLA Climate Action Commitment. With our plan, ASLA seeks to align with our fellow landscape architects worldwide and amplify our collective capacity to create positive change.

The Climate Action Plan is broken down into a framework around three main areas: Practice, Equity, and Advocacy.

Achieve zero emissions and double sequestration by 2040

Initiative Two: Climate Resilience Enhance capacity, biodiversity, and resilience of livable cities and communities
